Jennifer E. Acheson is a Pepperdine University Straus School of Law Institute for Dispute Resolution trained neutral who serves as both a private and panel mediator for San Mateo County Superior Court, and the California Court of Appeal, Sixth Appellate District. She is also a mediator and early neutral evaluator for the United States District Court for the Northern District of California. By appointment to the California Department of Insurance Mediation Program (Cal. Ins. Code §§10089.70-10089.830), she served as a highly successful mediator for the resolution of first party insurance coverage catastrophic loss disputes. Ms. Acheson has subject matter expertise in personal injury (auto and other), business/breach of contract, real estate, wills/trusts litigation, Americans with Disabilities Act of 1990; and parallel California State statutes, Unruh Act (California Civil Code §51 et seq.), and Denial of Full and Equal Access to Public Facilities (California Health & Safety Code § 19955 et seq.)
